Entries must be received by 6:00 pm CDT Wednesday, Wednesday April 3 after which time no entries may be accepted, cancelled, altered, or substituted. No telephone or verbal entries will be accepted. All changes and cancellations must be received in writing (email is acceptable) prior to closing, except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows published by the American Kennel Club.

All entries must be on official AKC entry forms. Entries will be returned if they are illegible, incomplete, are submitted with incorrect fees, or are photocopied without the reverse side instructions and agreement included. Checks returned for insufficient fees will have the entry cancelled: acceptance of such an entry will only be made if the full fees, plus a \$25 administrative fee, are paid via certified check or money order & received prior to the start of judging. Express deliveries must include signature waiver permitting them to be left at the Secretary's address without receipt signature. Entries received without signature release will be returned.

Entries with email addresses will be acknowledged with an email receipt. CAPER is not responsible for non-delivery of emails due to delivery errors or spam blockers, and no further efforts will be made. Confirmations and judging schedules will be emailed after closing.

Refunds: Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date; in the event that a dog is absent, disqualified, excused by the veterinarian or judge, or barred from competition by the Show Committee; or in the event that extreme weather conditions, riots, civil disturbances, or other acts beyond the control of the Show Committee make it impossible to open or complete the show/trial.

Fax/email/online entries: Entries may be faxed to the Show/Trial Secretary at 262-500-5080, or emailed to secretary@caper-dogs.com. Both sides (the entire page) of each entry form must be included, completely filled out and signed, or the entry will not be accepted.

Online entries are via the Online Entry link at www.caper-dogs.com.

Payment is made via PayPal or credit card by going to www.caper-dogs.com/PayPalCCpayment. htm and following the instructions there. Payment must include the \$2 per class additional charge to be valid.

Entry Errors: Exhibitors are responsible for the correctness of entries. All entries which include an email address will be sent an entry verification email shortly after receipt. All errors will be corrected prior to closing; exhibitor errors discovered after closing cannot be corrected. Duplicate entries will not be refunded after closing. Overpayments of less than \$5 per dog will not be refunded.

Transfers to higher levels: Transfers are available to dogs which, according to their owner's records, have completed the requirements to advance to a higher level after the closing date, in any offered sport. Each of these transfer requests must be made to, and accepted by, the Show/ Trial Secretary at least 30 minutes prior to the start of judging for which the transfer is requested.

SITE HOUSEKEEPING RESPONSIBILITIES FOR MEMBERS AND DOGS

- 1. All dogs left unattended in hotel guest rooms must be crated
- 2. Group will provide sheets of plastic to place under the crates. Up to four dogs will be permitted per
- Housekeepers will not have to service rooms in which dogs are loose and unattended. Moreover. they will be required to report this rule violation to hotel management. A pet deposit of \$50 will be charged for each room in which a dog is housed per stay. Individual room occupants will be assessed for any damage or destruction to their room.
- 4. Dogs must be bathed in designated areas for dog washing. There will be no grooming of dogs in hotel rooms and no hotel towels will be used for this purpose.
- 5. Group will assign a liaison to meet daily with the Head of Housekeeping and hotel management to assure that all of its members are complying with hotel rules. Any offenders will be asked to leave hotel immediately.
- 6. Dogs will not be permitted in any of the hotel recreation areas, including the swimming pools, and any other areas to be stipulated as "non-dog" locations.
- 7. Dogs will not be permitted in food and beverage outlets, with the exception of those assisting the disabled.
- 8. No exercise pens are permitted around the front of Royal Canin Ring or the Holiday Inn Hotel and exercise pens around the perimeter of the entire building are strongly discouraged.
- 9. The hotel will provide trash receptacles in the designated exercised areas for deposit of waste.
- 10. Group will provide plastic bags and appropriate scoops, etc. for the collection of waste.
- 11. Pick up and removal of waste will be the responsibility of each dog owner/handler.
- 12. Group will appoint a Grounds Committee to continuously monitor all exercise areas to assure that members comply with the rules.
- 13. Convention Center doors must be closed during event hours for safety of the dogs, Royal Canin Ring/Holiday Inn Roberts Centre will take no responsibility to insure doors remain closed.

SHOW SITE INFORMATION

Building Hours: Monday - Friday - open 6:30 am to 10:30 pm or until last SCA event is complete.

All dogs must be removed from the show site immediately after completion of SCA events each day. No dogs will be allowed in the restrooms.

If you plan to leave dogs unattended in your setup, a phone number that you can be reached at must be visibly posted in your setup in case of emergency.

No dogs are to remain in the show/grooming overnight.

GROOMING & ELECTRICITY

All paid grooming is sold out but there are plenty of free spaces with electricity available. If you have a paid spot, you cannot also have a free spot. You cannot save a spot for a friend. If you want to be next to each other, you should arrive together. The grooming setup will be available Sunday, April 21 as soon as the show committee has finished taping out the grooming areas, which will probably be late afternoon or early evening.

CLEAN-UP IS YOUR RESPONSIBILITY

If your dog soils the parking lot or show grounds, it is your responsibility to clean up after it. By signing the entry form at this show you are agreeing that all clean-up is your responsibility.

Violators may be subject to an event committee hearing. Exhibitors, please, if you see an area that has not been cleaned up, notify a show official immediately. Thank you.

Exhibitors and handlers will be responsible for clean conditions in and around their crates and are expected to comply with all Club rules as laid out and enforced by the SCA. Damage to hotel or show grounds property will be subject to Show Committee Hearing and action.

EXHIBITORS PLEASE NOTE! THE FOLLOWING PERTAINS TO ALL EVENTS!

The clubs, hotel, and any of their agents or employees will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property, & further assume no responsibility for injury to children. The Schipperke Club of America Inc. does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

RINGSIDE: Dogs may arrive at any time prior to their scheduled time of judging. Dogs not required for further judging will be excused. Judges will not wait for any dog. Owners and agents alone are responsible for the presence of their dogs at ringside when their class is called. The club, judges, stewards and secretary have no obligation or responsibility to announce for or locate dogs that are not at ringside when required.

Exhibitors should follow their Veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Classes divided by sex. Entrants may be altered. Winners eligible to compete for Best of Breed. 8 yrs & under 10 yrs • 10 yrs & under 12 yrs • 12 years & over

Award of Merit: At the judge's discretion, up to 5 dogs/bitches who have competed in the Best of Breed judging may be selected to receive an Award of Merit after BOB, BOS, BOW and Selects are awarded.

Best Puppy, **Best Bred By Exhibitor**, **Best Veteran**: 6-9 & 9-12 Puppy class winners will compete for Best Puppy. BBE Puppy & Adult class winners will compete for Best BBE. Veteran class winners will compete for Best Veteran.

National Specialty Reserve Winners Dog & Bitch will receive 3 championship points if the total entry in each sex is at least twice the number of entries needed for a 5 point major.

Non-Regular Classes (multiple dog entries)

Winners of these classes are not eligible to compete for Best of Breed. Altered dogs may be entered.

Stud Dogs

Brood Bitches

Dogs/Bitches shown with two of their offspring.

Class is judged on the merits of the offspring, but the parent will be examined for DQs/excusals.

Offspring must be entered in a regular conformation class.

Entry is made for the Stud Dog or Brood Bitch - offspring are not entered on the entry form.

Brace Class

For two dogs, regardless of sex, performing in unison and presented by one handler.

Both dogs in each Brace must have at least one common owner.

Entrants need not be entered in any other class, but each must be on a separate entry form.

Team Class

For four dogs, regardless of sex, performing in unison and presented by one handler.

All dogs in each Team must have at least one common owner.

Entrants need not be entered in any other class, but each must be on a separate entry form.

JUNIOR SHOWMANSHIP

<u>Novice class</u>: For junior handlers aged 9-17 who, at the time entries close, <u>have not</u> won three first place awards, with competition present, in a Junior Showmanship Novice class at a licensed or member show.

Open class: For junior handlers aged 9-17 who, at the time entries close, <u>have</u> won three first place awards, with competition present, in a Junior Showmanship Novice class at a licensed or member show.

<u>Master class</u>: For junior handlers aged 9-17 who, at the time entries close, have 10 first place wins in an Open class with competition. The calendar for this class will be November 1 - October 31 of the following year. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

PLEASE NOTE: Juniors must include their AKC Junior Handler number on the entry blank. Be sure all information for Junior Showmanship Classes is entered on the <u>front and back</u> of the entry form. Dogs shown in Junior Showmanship may have Full or Limited AKC registration or have an ILP/PAL number. Altered animals are eligible to be shown, but bitches in season are not eligible.

SWEEPSTAKES

Puppy Sweepstakes

Puppy Sweepstakes is open to all Schipperkes who are 6 months but less than 18 months old on the day of the sweepstakes. Dogs must also be entered in one of the 2024 National Specialty regular classes at the regular entry fee. Classes are divided by sex.

6 mos & under 9 mos • 9 mos & under 12 mos • 12 mos & under 18 mos

Veteran Sweepstakes

Veteran Sweepstakes is open to all Schipperkes who are at least 8 years of age on the day of the Sweepstakes. Entrants may be altered and need not be entered in a regular class. Classes are divided by sex.

8 yrs & under 10 yrs • 10 yrs & under 12 yrs • 12 years & over

DISTRIBUTION OF SWEEPSTAKES PRIZE MONEY (both Sweepstakes)

35% of total entry fees will be retained by Club for expenses.

The remaining 65% (for each Sweepstakes) will be awarded as follows:

Best in Sweepstakes 10% of total Sweepstakes entry
Best of Opposite Sex in Sweepstakes 5% of total Sweepstakes entry

Placements receive a percentage of the remaining entry fees of the class entered: First Place - 40% • Second Place - 30% • Third Place - 20% • Fourth Place - 10%.

All cash prizes rounded to nearest dollar amount. Undistributed funds revert back to SCA.

FUTURITY

The purpose of the Futurity is to encourage the breeding of the best possible Schipperkes and to reward the breeders for their efforts. Prize monies are therefore divided between the owners and the breeders. The Futurity stake is for any properly nominated and entered Schipperke that is at least six months old and less than 18 months old on the date of the Futurity competition. They MUST be entered in one of the Regular Classes in the National Specialty show.

Indicate the Futurity class, with age division, in the space provided for Additional Classes on the entry form. Champions of record are eligible to compete. Classes are divided by sex

6 mos & under 9 mos • 9 mos & under 12 mos • 12 mos & under 18 mos

MATURITY

The Maturity is designed to be educational and a complement to the Futurity. By bringing back the previous Futurity nominees and showcasing them as adults, breeders will have the opportunity to see not only how individual dogs have developed, but also how particular bloodlines grow and mature. The Maturity is for adult dogs that came from nominated litters. They need <u>not</u> have been shown in the Futurity, but <u>must</u> have been part of a Futurity nominated litter. Entrants need not be entered in the regular classes and may be altered.

Best in Maturity winners will not be eligible to compete in future Maturity events.

Indicate the Maturity class, with age division, in the space provided for Additional Classes on the entry form.

Maturity Challenge Classes - open to all qualified dogs and bitches that were Futurity eligible the immediately preceding National Specialty to eight years old. Classes divided by sex.

Maturity Class 1 - Dogs and bitches that were Futurity eligible the immediately preceding National Specialty & under four years old on the date of the event.

Maturity Class 2 - Dogs and bitches that are four years old & under six years old on the date of the event.

Maturity Class 3 - Dogs and bitches that are six years old & under eight years old on the date of the event.

DISTRIBUTION OF FUTURITY/MATURITY PRIZE MONEY

All monies from nominations and entry fees (less 35% withheld for SCA expenses) will be divided as follows:

Best in Futurity/Maturity 15%

Best of Opposite Sex 5%

Owner of Sire of Best in Futurity/Maturity 5%

Breeder of Best in Futurity/Maturity 15%

Class monies will be divided: First 40%, Second 30%, Third 20%, Fourth 10%

FOUR-TO-SIX MONTH BEGINNER PUPPY COMPETITION

The Four-to-Six Month Puppy competition shall be for Schipperkes that are 4 months of age but under 6 months on the day of the event. An AKC registration number or litter number will be required for each entry. A foreign born dog may enter this class if they are registered in the country of origin.

- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete for awards in this class. but must be handled by a non-professional handler. Dogs may not be exhibited by current assistants and household members of a professional handler. Professional handlers are defined as any person who belongs/has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last 5 years.
- All entries must be received by the closing date. No entres will be taken at ringside.

PARADES

Parade of Titleholders

Any Schipperke with an AKC title may be entered in the Parade of Titleholders. The entry form must indicate "Parade of Titleholders"

Parade of Rescues

Any Schipperke that has been placed in its home through a rescue organization, animal shelter, SPCA, etc. may be entered in the Parade of Rescues. The entry form must indicate "Parade of Rescues."

Parade of Veterans

Any Schipperke that is 7 years or older, regardless of titles, may be entered in the Parade of Veterans. The entry form must indicate "Parade of Veterans."

Each Parade entrant will receive a commemorative item.

For all Parades: Entries are \$20 each and are to be sent to the Show Secretary on the show entry form in the Premium List or entered online on Caper's website. Entry deadline is April 3rd.

In addition, a description of the dog's achievements will be read while the dog is presented. A brief owner-provided biography (100 words or less, please) must be sent to Diane Harris at whenspiritstalk@ aol.com or mailed to her at 7664 Tomotley Road, Maryville TN 37801. Deadline for the biographies is March 10th.

- 2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name.
