If placed on pavement, plastic MUST BE USED underneath and the area must be swept clean at departure. Public Ex Pens will be available just out the south door of the grooming area.

#### **All Exhibitors Please Note!!**

Dogs MUST BE CRATED when unattended in the guestrooms. Damages to the room are the responsibility of the occupant and must be settled with the hotel prior to departure.

NO BATHING OR GROOMING OF DOGS ALLOWED IN HOTEL GUEST ROOMS. If there is any grooming found by the hotel staff or show committee, you could be asked to leave. An outdoor dog wash area will be provided; bathing products are the responsibility of the owner.

Exercise dogs ONLY in the designated areas. Please clean up after exercising your dogs; equipment will be provided for your convenience. NO dogs will be allowed in the public areas, restrooms, courtyard or restaurants

Dogs must be on leash at all times or confined to their crates, except when being judged or groomed.
