**Day of Show Entries will be taken from 7a.m to 7:45 am. each day.**

### Directions to the Show:

**From the North:** Take 43 South to 94 East to 794 South to Howard Ave exit. Left 1 block to Pennsylvania Ave. Left on Pennsylvania Ave. 1 block to Cudahy Kennel Club on the right.

**From the South:** Take 94 West (head North) to Howard Ave. Exit right on Howard Ave. and continue until Pennsylvania Ave. Turn Left on Pennsylvania, 1 block to Cudahy Kennel Club on the right.

**From West:** 94 East to 794 South to Howard Ave exit. Left 1 block to Pennsylvania Ave. Left on Pennsylvania Ave. 1 block to Cudahy Kennel Club on the right.

Head W on E Crawford toward S Pennsylvania Ave. Turn L onto S Pennsylvania Ave. Turn R onto E Howard Ave. Turn L onto the I-43S/ I-94 E/ US 41 S ramp. Merge onto I-43/I-94 E. Take exit toward Beloit. Continue on I-41/I-43S/i-894W. Keep on I-41/I-894 W – follow signs for I-894N/US-45N. Take exit 3 for Beloit. Turn L onto Beloit Rd. Turn R onto 108<sup>th</sup> St to Vet Clinic.

### General Information/Rules

Please pick up after your dog and dispose of waste in appropriate containers outside the building. Please be considerate by picking up after your dogs and leaving the grounds as you found them. Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement per BHA regulations.

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, may be asked to leave the trial site. In that case, no refund of any fees paid will be made.

**Smoking is not allowed Building or on the grounds. If you must smoke, you will need to do so inside your vehicle and dispose of the butts in the vehicle.**

If bringing a bitch in season, please inform the trial committee prior to the trial, and you must inform all exhibitors at the judge's briefing.

Dogs that are loud and/or disruptive may be asked to locate away from the rings/crating area and/or staged away from the other dogs getting ready to compete.

The club will **NOT** have food for sale.

### Volunteers:

Volunteers are very important to any Barn Hunt Trial. We will make sure that you have enough time to walk your dog before you run.
