## JUDGING PROGRAM

Judges are not required to wait for dogs. They will adhere as closely as possible to the judging schedule printed in this program. The owner or handler of each dog is solely responsible for having their dog ready at ringside at the scheduled time. The Club will not be responsible for and is not obligated to call or locate dogs that are not brought into the ring when required. Break for lunch to be determined by the judge.

### TRANSFER OF ENTRIES

Entrants wishing to transfer from Regular conformation classes to Best of Breed, Junior Show entrants wishing to move to Open or Master, or Rally/Obedience entrants wishing to move up to the next level of competition, must submit their requests in writing to the Secretary no later than 30 minutes prior to the start of judging for the day.

### SETUP INFORMATION

The building will be available for setup on Friday from 6-8pm **only**. Note this is for setup **ONLY** - no grooming or ring practice. The building will open at 6:30am Saturday & Sunday.

Sweepstakes and Conformation classes will be held in a room off the front of the building.

**Chalking is allowed in the grooming area but you MUST use a tarp on the floor to collect all chalk. NO chalking outside.**

Obedience and Rally events will be in a separate room from conformation, with separate parking and entrance off the back of the building. **No parking on the side of the building.**

No dogs are to be left in the building overnight. Crates & equipment are left at your risk.

**EXHIBITORS ARE RESPONSIBLE FOR CLEANING UP AFTER THEMSELVES & THEIR DOGS!**

Complimentary coffee and donuts will be available in the morning. Soda and water will be for sale the entire day. Lunch will be available for purchase during normal lunch times.

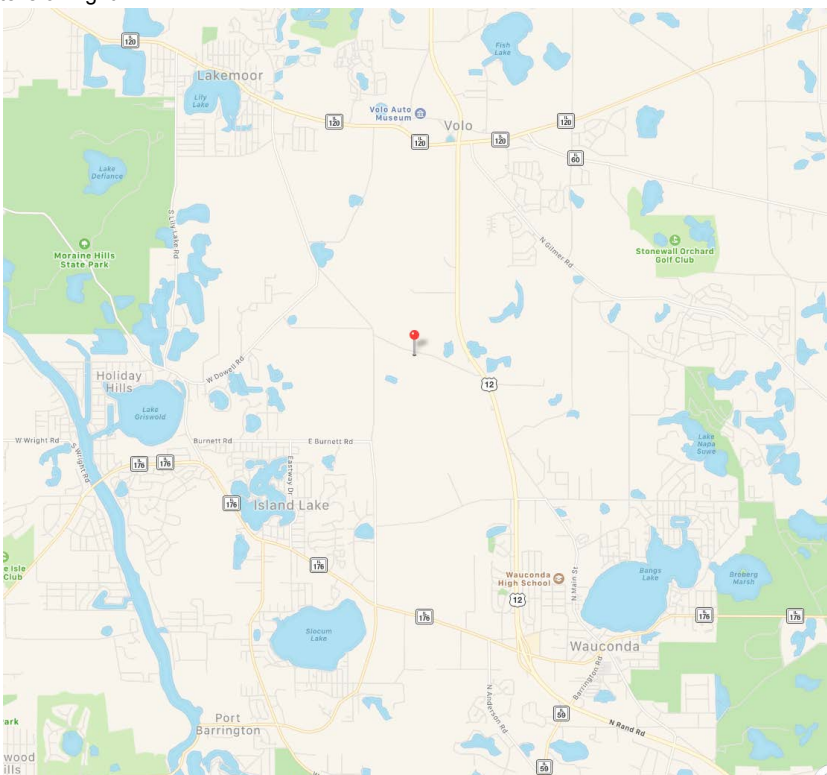
**DIRECTIONS TO SITE**

**From Milwaukee:** I-94 south to IL Hwy 120. West on 120 to Hwy 12. South on 12 to Case Rd, turn right. Site is on the left.

OR toll-free route: I-94 south to Hwy C/Wilmot Rd, west to Hwy 83, turn left. 83 into Antioch, right onto Hwy 59, continue onto Hwy 12 to Case Rd, turn right. Site is on the left.

**From the South/Southwest and East:** I-90 to the IL-53 exit toward NW Suburbs. Follow signs for Kirchoff Rd & merge right onto IL-53 N. North 7.7 miles to Lake Cook Rd. Exit on left, go west <1 mile to Rand Rd/US-12W, turn right. Travel 12.9 miles to W Case Rd. Turn left, site is on the left.

**From the West:** US-20 E to Marengo; left onto IL-23N/S State St. for half a mile. Right onto IL-176E/Telegraph St.; follow IL-176 east 24 miles to N Darrell Rd, turn left. In 2.4 miles turn right onto W Case Rd. Site is on right.
