By **PayPal or credit card** at caper-dogs.com, PayPal/Credit Card link. Please send a separate payment for the total of each dog's entries. **Payment** <u>must</u> include \$2 per class additional charge for the entries to be valid.

Entries must be received by 6:00 pm CDT Wednesday, July 23 after which time no entries may be accepted, cancelled, altered, or substituted. No telephone or verbal entries will be accepted. All changes and cancellations must be received in writing (email is preferred) prior to closing, except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows published by the American Kennel Club.

All entries must be on official AKC entry forms. Entries will be returned if they are illegible, incomplete, are submitted with incorrect fees, or are photocopied without the reverse side instructions and agreement included. Checks returned for insufficient fees will have the entry pended; acceptance of such an entry will only be made if the full fees, plus a \$25 administrative fee, are paid via Zelle, PayPal, certified check or money order & received prior to the start of judging. Express deliveries must include signature waiver permitting them to be left at the Secretary's address <u>without receipt</u> <u>signature</u>. Entries received without signature release will be returned.

Entries with email addresses will be acknowledged with an email receipt. CAPER is not responsible for non-delivery of emails due to delivery errors or spam blockers, and no further efforts will be made. Confirmations and judging schedules will be emailed after closing.

Refunds: Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date; in the event that a dog is absent, disqualified, excused by the veterinarian or judge, or barred from competition by the Show Committee; or in the event that extreme weather conditions, riots, civil disturbances, or other acts beyond the control of the Show Committee make it impossible to open or complete the show/trial. Refunds will be made, less \$5 per entry, for bitches entered in obedience or rally who come into season after the closing date, if written notice is given to the secretary at least 30 minutes prior to the start of obedience/rally classes.

Entry Errors: Exhibitors are responsible for the correctness of entries. All entries which include an email address will be sent an entry verification email shortly after receipt. All errors will be corrected prior to closing; exhibitor errors discovered after closing cannot be corrected. Duplicate entries will not be refunded after closing. Overpayments of less than \$5 per dog will not be refunded.

Transfers to higher levels: Transfers are available to dogs which, according to their owner's records, have completed the requirements to advance to a higher level after the closing date, in any offered sport. Each of these transfer requests must be made to, and accepted by, the Show/ Trial Secretary <u>at least 30 minutes prior to the start of judging for which the transfer is requested.</u>

Winners of these classes are not eligible to compete for Best of Breed.

Stud Dogs Brood Bitches

Dogs/Bitches (may be altered) shown with two of their offspring. Class is judged on the merits of the offspring, but the parent will be examined for DQs/excusals. Offspring must be entered in a regular conformation class. Entry is made for the Stud Dog or Brood Bitch - offspring are not entered on the entry form. Stud Dog/Brood Bitch as only entry \$32, as additional entry \$25

Brace Class

For two dogs similar in appearance, performing in unison and presented by one or two handlers. Both dogs in each Brace must have at least one common owner. Entrants MUST be entered in an additional Conformation class.

Other Conformation Awards

Award of Merit: At the judge's discretion, up to 2 dogs/bitches who have competed in the Best of Breed judging may be selected to receive an Award of Merit after BOB, BOS, BOW and Selects are awarded.

Best Puppy, Best Bred By Exhibitor, Best Veteran: 6-9 & 9-12 class winners will compete for Best Puppy. BBE class winners will compete for Best BBE. Veteran class winners will compete for Best Veteran.

National Specialty - Points For Reserve Winners

At the National Specialty the dog designated Reserve Winners Dog and the bitch designated Reserve Winners Bitch will be awarded a three-point major, provided that the number of dogs competing in the regular classes of the Reserve Winner's sex totals at least twice the number required for a five point major, in the region in which the event is held. 12 dogs & 12 bitches are required for Points for Reserve Winners at this specialty.

JUNIOR SHOWMANSHIP

<u>Novice class</u>: For junior handlers aged 9-17 who, at the time entries close, <u>have not</u> won three first place awards, with competition present, in a Junior Showmanship Novice class at a licensed or member show.

Open class: For junior handlers aged 9-17 who, at the time entries close, <u>have</u> won three first place awards, with competition present, in a Junior Showmanship Novice class at a licensed or member show.

<u>Master class</u>: For junior handlers aged 9-17 who, at the time entries close, have won the 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be November 1 - October 31 of the following year. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

PLEASE NOTE: Juniors must include their AKC Junior Handler number on the entry blank. Be sure all information for Junior Showmanship Classes is entered on the <u>front **and** back</u> of the entry form. Dogs shown in Junior Showmanship may have Full or Limited AKC registration or have an ILP/PAL number. Altered animals are eligible to be shown, but bitches in season are not eligible.

Please enter your dog's jump height on the entry form for all classes with jumps. These classes will run small to tall heights.

Transfers to the next higher level in both obedience and rally are allowed per AKC rules and regulations. Bitches entered in obedience or rally who come into season after closing will receive a refund of entry fees, less \$5/entry, if written notice is given to the secretary at least 30 minutes prior to the start of judging.

PUPPY SWEEPSTAKES

Puppy Sweepstakes is open to all AKC registered American Water Spaniels who are at least 6 months of age and under 18 months of age on the day of the Sweepstakes. Entrants must be entered in a regular class. AKC Champions of record are permitted. List the entered Sweepstakes class in the <u>Additional Entry</u> box on the entry form.

Classes are divided by sex.

6 mos & under 9 mos • 9 mos & under 12 mos 12 mos & under 18 mos

35% of total entry fees will be retained by the Club for expenses. The remaining 65% will be awarded to class placements as a percentage of the entry fees of the class entered: First Place - 40% • Second Place - 30% • Third Place - 20% • Fourth Place - 10%. All cash prizes rounded to nearest dollar amount. Undistributed funds revert back to the Club.

4-6 MONTH BEGINNER PUPPY

The Four-to-Six Month Puppy competition shall be for American Water Spaniels who are four months of age but under six months on the day of the event. An AKC registration number or an AKC litter number will be required for each entry. A foreign born dog may enter this class if they are registered in the country of origin.

• All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.

• Professional handlers are not permitted to exhibit in this class. Professional handlers are defined as any person who belongs/has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last 5 years.

• Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers who are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in this class.

• All entries must be received by the closing date. No entres will be taken at ringside.

• Exhibitors should plan on opening the mouth of their puppies for the judge.

• Breed standard disqualifications such as color, height, weight or dentition shall not be a point of considerationin the judging process for this competition.

AKC NATIONAL OWNER-HANDLED SERIES

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

All dogs that are owner-handled and are not owned, co-owned or exhibited by professional handlers* meet the requirements for this competition. Exhibitors must declare their dogs are Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and assistants to current professional handlers may not exhibit the dog in any breed competition during the entire show.

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

* Professional handlers are not permitted to exhibit in this competition. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay. or received payment for handling a dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.

INSTRUCTIONS

- 1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- 2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- 5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/ Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
