From North: 41 S to Exit #145 /WI 441 S, Take Oneida St exit. Stay on S. Oneida Rd or US-10, turn left onto Manitowoc Rd.

JUDGING PROGRAM

Judges are not required to wait for dogs. They will adhere as closely as possible to the judging schedule printed in this program. The owner or handler of each dog is solely responsible for having their dog ready at ringside at the scheduled time. The Club will not be responsible for and is not obligated for providing service through a public service system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

TRANSFER OF ENTRIES

Handlers who wish to transfer their dogs to a higher level class in conformation or junior showmanship must notify the Show Secretary in writing at least 30 minutes prior to the start of that day's judging.

SETUP INFORMATION

The show site will be available at 1:00 pm on Friday and at 8:00 am on Saturday and Sunday.

No grooming tables, pens or exhibitors' setups will be allowed in the aisles and all grooming must be done away from the judging ring in areas specified by the club. Private exercise pens are allowed in the grooming room during show hours.

No practicing allowed in rings at any time.

No dogs can be left on premises. Do not leave dogs in closed vehicles.

Limited RV parking overnight on the show grounds. No hook ups or electric
